

FMW Renovation Update

The quest for permits continues.

There are two permits we seek. The site permit request, prepared by Gordon Civil Engineering, covers the excavation, grading, drains, etc. With this permit in hand, we can issue a Notice to Proceed and move forward with the work.

The building permit request, prepared by Gauthier Alvarado Associates, is a little less urgent.

Monday

We begin the week believing that we have submitted everything needed, that we have approval from all reviewers, and that the site plan, at least, is in final QA, which is said only to take a day or two. It is now day three and no word.

Tuesday

We discuss more pleasant things. Should the inside of the elevator be enamel, stainless steel, or "wood"? Do we have to have compact fluorescent lights in the cab? Are they easy to replace?

We ask Shaun (who runs the DCRA ProjectDox computer permit system) what's up. It appears the computer is not convinced that the final reviewers have approved.

Suddenly the computer kicks both permit requests back out to us, grumbling that the resubmittals did not meet the requirements for resubmittals, so we better resubmit them.

Apparently, this is necessary to launch new review cycles, so the remaining reviewers can see the plans in their queues and approve.

Gordon resubmits their plan. GAA uploads some more documents.

ProjectDox lists all sorts of pending approvals, but it gradually emerges that we need signoff from Tiffany of DDOT (for the site permit) and from Charles of DOEE and Daniel of Zoning (for the building permit).

Wednesday

We meet with the architects and contractor, Monarc Construction. Monarc gloomily remarks that the cost of the project will likely be going up as we now will be finishing the outdoor construction in winter weather.

The ProjectDox computer shows that the site permit is now in review cycle 2.

ProjectDox lists all sorts of pending approvals, but it gradually emerges that we need signoff from Tiffany of DDOT (for the site permit) and from Charles of DOEE and Daniel of Zoning (for the building permit).

We ask Tiffany if she can approve. She asks us for a permit number we provided two weeks ago. We provide it again.

Tiffany responds that she still can't see the permit request in her queue.

ProjectDox settles down to say that all it wants is approval from DDOT, but it now shows a new reviewer — DeAngelo. Tiffany says DeAngelo doesn't work there anymore.

Shaun says now anybody in Tiffany's department should be able to approve.

We finally reach Daniel, after many, many calls. He says he will check to see if he thinks the Building permit is ready to approve, but he notes that he can't see it in his queue.

Shaun says the building permit plans need to be resubmitted so review cycle 5 can fire up and Daniel can see the request again.

Thursday

Building permit review cycle 5 is launched. Now Daniel can see the request to approve it. We call Daniel. His phone message says that he will be back in two weeks.

We send a note to Charles of DOEE suggesting that he look in his queue for our request and bless it.

Tiffany, who always answers the phone right away, does not answer the phone all day. Neither does Charles.

Monarc Construction has been busy doing what they can to prepare for the possibility that we may someday have a permit (cutting our office in half and so on). Accordingly, they give us their first monthly payment request, for \$80,189. We pay 90% of that now and keep \$8,019 as a kind of deposit to be paid at the end of the job.

We notify the bank construction manager, who responds with a paralyzing list of documents they would like to see before advancing mortgage money to our account.

Friday

Charles resurfaces.
